Introduction, a note on Methodology

This report provides a comprehensive view of the current conditions of the city of Youngstown, particularly in comparison to Mahoning County and the state of Ohio at large.

The data utilized in this report is primarily compiled from the American Community Survey (ACS), which is a product of the US Census. The most accurate data points from the ACS are created from 5-year trends. Thus, many data points are listed as 2023 ACS 5-year Estimates.

Other data points come from a variety of publicly available federal or corporate sources. The most recent available data is always listed and source cited.

Much of this report displays data for City of Youngstown, Mahoning County and the State of Ohio. In order to provide a baseline that can be updated in the future without the use of proprietary, subscription-based software, the report does not measure Mahoning Co. as "everywhere in Mahoning Co. except Youngstown". In other words, Youngstown is part of the Mahoning Co. data. This will slightly skew data, but even with the inclusion of Youngstown, the data show that the county, at large, is Whiter and more economically prosperous than the City.

Similarly, all state of Ohio data include Mahoning County. A condensed presentation of key data points can be found at the end of this report.

Population Demographics

Population by Race and Ethnicity in Youngstown, Mahoning Co. and Ohio




Figure 1. Population by Race comparing Youngstown, Mahoning, and Ohio, 2023

While Mahoning County as a whole has a racial distribution quite similar to Ohio, Youngstown has significantly larger minority populations, particularly African American or Black (Figure 1). Just over 40% of the city's population identified as Black or African American alone according to ACS 2023 5-year estimates.

Less than 15% of county or state residents self-identify as Black or African American.

Youngstown has a greater rate of Hispanic or Latinx residents than the county or state, however has less residents that identify as Native American, Asian or Pacific Islander alone. The

distributions of these populations have remained largely the same since 2020, with most experiencing slight growth since 2020. However, the White Alone population decreased by 1.6% from 2020 to 2023.

The remaining data points in this report focus on the White, Hispanic or Latinx and Black/African American populations. GOPC acknowledges the cultural significance of minority populations that have not been represented in the rest of this report and notes that their omission is not a matter of negligence, but a choice made to make data readable and digestible. We do not believe that the population size of these communities is statistically significant enough that their exclusion would dramatically affect the data as presented.

By Age

Median Age in Youngstown and Mahoning Co. in 2023

Since 2020, the median age of Mahoning County has remained almost the same, as has the state, however the median age within the city of Youngstown has decreased with estimates reflecting a change from 39.8 to 37.8. Youngstown's decrease in median age is occurring outside the margin of error, meaning even when the extremes of the margin are accounted for, data shows the populations in Youngstown getting slightly younger. Quantitative data alone cannot identify a singular cause as to why the city's population has gotten slightly younger.

Age Distribution in Youngstown and Mahoning Co.







Figure 2a. Total Population Pyramid of Youngstown City, 2020




Figure 3a. Total Population Pyramid of Mahoning County, 2020

Featured in this section are four population pyramids: two for the City of Youngstown (Figures 2a - 2b) and two for Mahoning County (Figures 3a - 3b). Using these models, we can identify how the distribution of ages has changed within the city over the past 4 years.

HOW TO READ A POPULATION PYRAMID

Population pyramids can be a useful tool in visualizing how a population may be changing in a region. Its shape can tell whether a population is stable, growing, or going through a period of decline.

However, a population pyramid <u>cannot</u> communicate **migration patterns** or **mortality rates**.

This is an example of a population pyramid. An ideal population pyramid will take a pyramid shape, with larger base layers that shrink as you move up through the age cohorts, indicating a growing population. If the pyramid's base layers are smaller than higher layers, then the population is declining.



Population pyramids can also provide an estimation of how much of the population will be economically dependent (e.g. seniors and children are dependent on other sources of income besides employment paychecks) to help assess population needs.

You can also identify discrepancies in a geography's gender distribution using population pyramids, as the **left** side shows the male population, and the **right** shows the female population.

Overall, the shape of Youngstown's population pyramid is considered "stable" (Figure 2b), meaning that the birth rate is sufficient enough to replace aging cohorts, but there is no excess that would count toward growth. This is typically a sign of a lower birth rate and longer life expectancy. Youngstown, as well as Mahoning County, has an aging population, and can expect some increased strain from a dependent elderly population over the next 10 years.

The gender distribution of the city and county are fairly even, although there tends to be slightly more women across most age cohorts.

Mahoning County has not seen a similar surge of population in the aged 15-24 cohort as the City of Youngstown has (Figures 3a & 3b).




Figure 3b. Total Population Pyramid of Mahoning County, 2023

Population Change in Youngstown and Mahoning Co. and Potential Impacts of COVID

The city of Youngstown's population has continued to shrink since 2020. While the numerical rate has decreased, there has been relatively more decline when compared with the previous decade due to the difference of time period. This high percentage change is the result of a spike in losses, likely partially due to out-migration from the pandemic.

Mahoning County's population decline has slowed, suggesting its population has stabilized. This loss (-0.61%) from 2020 to 2023 is approximately -1,400 people. During the same period there were approximately 1,300 deaths attributable to Covid-19.¹

The loss of population in Youngstown from 2020 to 2023 is significant. GOPC suggests additional research on migration flows be conducted to further understand the dynamics and potential causes of Youngstown's continued population loss.

Tenure of Housing

Tenure of Housing: Owner Occupants and Renters in the City, County and State

The city of Youngstown has lower rates of homeownership than the county or state. However, homeownership has slightly increased across all geographies since 2020. The most recently available data show that approximately 56.93% of households in the city are homeowners, while 70.93% of households in the county are homeowners and 67.55% of households statewide are homeowners.




Figure 4. Tenure of Housing by Geography, 2023


Tenure of Housing by Race in Youngstown, Mahoning Co. and Ohio, 2023

Efforts to close the gap in homeownership among Black and Hispanic and Latinx subpopulations have shown to be effective with small increases in homeownership rates among these households. However, both minority groups remain majority-renter as opposed to their White counterparts (Figure 5).

There is a large disparity in homeownership between White and Black or African American households. Among renters in Youngstown, 51.8% are Black/African American, while 31.5% of renters are White alone households. Two out of every three White alone households are homeowners (70%), while less than half of Black/African American households (45%), and Hispanic and Latinx alone households (47%) are homeowners.

Housing Values and Vacancy

Housing Sales Prices, 2024

As of December 2024, home prices in the City of Youngstown were up 12.1% compared to the previous year, selling for a median price of \$159,703.² Countywide, the median sales price for homes in December 2024 was \$171,560 which was 14% greater than 2023.³ Ohio's median sales price for homes in December 2024 was \$247,700, an 8.6% increase year over year.⁴ Increases in sale prices have been larger than they were in 2022 across the state, when GOPC last conducted this analysis. Mahoning County saw a significant comparative increase in sales price than 2022 (6.2%), however the city of Youngstown's increase in median sales price was more modest comparatively (17.5% in 2022).

Fair Market Rent, 2024

In 2024, the fair market rent for a 2-bedroom apartment in Mahoning Co (the smallest geography available) was \$860. Fair market rents are expected to continue to increase in 2025.⁵

Long Term Vacancy, 2023

In 2023, 10.91% of Youngstown's housing units were "other vacant," which is the Census's designation for abandoned, vacant properties that have no prospect of tenants or buyers due to their condition. This was 3,207 units; a 616 unit decrease within a three year period. This decrease in permanently abandoned properties within the city is a sign that blight removal efforts are proving effective and should continue in coming years.

The early 2010s were the high-water mark for 'other vacancy' in Ohio, as the impacts of the Great Recession reverberated across housing markets. Now, in 2025, rates are much lower in Youngstown and Mahoning Co. and the rest of the state for a variety of reasons, including: millions of dollars allocated to demolition, effective landbanks that have removed and prevented blight, increased code enforcement, and relief and support programs that have kept at-risk owners in their homes.

Household Income

Individuals' Wages, 2022

In 2022, 48% of individuals employed within Youngstown earned less than \$3,333 per month, or \$39,996, annually.⁶

Household Income in Youngstown, Mahoning Co. and Ohio

The City of Youngstown's median <u>household</u> income was \$34,746 in 2023. That is \$20,830 less than the county and nearly half than of the state (\$34,934 less). Across Youngtown, Mahoning Co. and Ohio, income has continually risen since 2010, and at a faster rate since 2020, comparatively. (For more on household income, see Appendix B)


Household Income in Youngstown, by Race


Looking at median household income by race, there are disparities among city residents. Hispanic and Latinx households are seeing the worst financial outcomes within the city. Only 18% of Hispanic and Latinx households in Youngstown earn more than the median income for White alone households (\$45,000), while 33% of Black or African Americans earn the same. The comparison between Black or African American households is even more stark. Black or African American households currently have the lowest median income in the county, sitting within the \$25,000 to \$29,999 income bracket (Youngstown, \$27,986; Mahoning, \$29,685).

The median income for Hispanic and Latinx households in Youngstown has remained within the same income bracket since 2020 (exact value \$20,855), however has increased within Mahoning County. Exact median income for all demographics can be found below (Table 7).

Also, the median income of White Alone households has increased at both the city and county level and Mahoning County is now in line with state trends. The exact median income reported for White Alone households in Youngstown is \$44,750 in 2023 inflation-adjusted dollars. An extended, numerical breakdown of household income, including the number of households in each bracket can be found in Appendix B.

Housing Cost Burden for Renting and Homeowner Households, 2017-2021

Housing cost-burden is when a household pays 30% or more of its income to housing expenses (mortgage/rent, utilities, taxes/fees).

The most recent data available is aggregated from data collected from 2017 to 2021 and does not adequately reflect the ongoing stress the pandemic and post-pandemic trends have put on

renters and some homeowners.

The data, which have limited value because of their age, suggests 49% of Youngstown city renters paid more than 30% of their income to housing expenses). Sixteen percent of all Youngstown city homeowners paid more than 30% of their income to housing expenses.⁷

Housing Wage for Renting Households, 2024

The hourly wage necessary to afford a 2-bedroom, fair market-rate apartment in Mahoning Co. increased to \$16.19/hour in 2024 (+\$2.35 since 2022). A household earning the average renter wage in the county needs to work 63 hours a week in order to afford the typical 2-bedroom fair market rent of \$860/month. A minimum wage earner would need to work 1.6 jobs to comfortably afford a 2-bedroom fair market apartment.⁸

Households Living at or Below the Federally Designated Poverty Rate, by Race

The Census Bureau defines poverty by using a set of money income thresholds that vary by size and composition of a family to determine who is in poverty. If a family's total income is lower than the threshold, which is calculated from the cost of a minimum food diet multiplied by three, then that family and every individual in it is considered in poverty. The official poverty thresholds do not vary geographically, but they are updated for inflation using the Consumer Price Index. In 2023, the poverty level for a single adult with two minor children was \$24,549.⁹

The Federal Poverty Threshold should not be confused with the Federal Poverty *Guidelines*. While both provide federal measures of poverty, the Federal Poverty Threshold is determined by the U.S. Census Bureau and includes statistics on the number of Americans who are living in poverty. This report is then used by the Department of Human and Health Services to establish the Federal Poverty Guidelines.

In Youngstown, 36.2% of households were below the poverty level. This is nearly double that of the county (18.3%) and significantly more than the state (13.2%). While the state has seen a slight decline in the poverty rate, both Mahoning County and Youngstown's poverty rates continue to increase since 2020.

Discrepancies between median income and poverty rate help identify internal wage gaps, since the median is the exact halfway point within a population. If poverty rate increases while median income either remains level or increases, it means that the number of households within the middle range of incomes is shrinking, while the number of households at either extreme grows.




Figure 7. Percentage of Households Below Poverty Level by Race, 2023

Information about Jobs held by Residents and Certified Companies in Youngstown

Top Five Industries Youngstown Residents Work in, 2022

The five industries that have the largest share of city residents in them are below. Health Care and Social Assistance is a massive industry within Youngstown, accounting for 31.4% of jobs held by residents, more than double the next largest industry, Educational Services. (For a full list, see Appendix C.)

MBE, WBE, VFBE, and EDGE Certified

There are four major business certifications through the Ohio Department of Administrative Services: Minority Business Enterprise (MBE), Women-owned Business Enterprise (WBE), Veteran-friendly Business Enterprise (VFBE or VBE) and Encouraging Diversity, Growth, and Equity (EDGE) certification.

Undoubtedly, many more Black-owned, Hispanic and Latinx owned, women-owned, and veteran owned businesses exist in Youngstown. Estimating those numbers, however, is difficult if the businesses are not registered for certification.

As of February 2025, Youngstown has:

- 33 state certified minority business enterprises
- 22 state certified women business enterprises
- 2 state certified veteran friendly business enterprises
- 28 state certified encouraging diversity, growth, and equity certified businesses

Some individual businesses qualify for multiple certifications, meaning the unique number of MBE, WBE, VFBE and EDGE companies is not the full sum of the numbers above. (For a complete list of companies with MBE, WBE, VFBE, and EDGE certification, please see Appendix D).

Conditions in Education

District Demographics

There are 14 schools in the Youngstown City District. Within the district, in the 2023-2024 school year, there were a total of 4,569 students enrolled. Of those students, half identify as non-Hispanic Black (51%), and a fourth identify as Hispanic (26%), while only 13% identify as non-Hispanic White (Figure 7).

Please note that American Indian/Alaskan Native, Asian/Pacific Islander, and Migrant populations are not represented, because their enrollment is less than 1% of the student body.

The district reports that 841 students (18.4%) have disabilities, and 383 (8.4%) are English learners.




Figure 8. Student Enrollment by Race in Youngstown City School District, by Year

District Classification as Economically Disadvantaged

The entire student body is considered economically disadvantaged; this designation means that the student in question meets any of the following conditions (as quoted directly from the Department of Education's EMIS Manual):

- Eligibility for Free or Reduced-Price Lunch. Students who are known to be eligible to receive the free or reduced-price lunch, a program through the United States Department of Agriculture (USDA) National School Lunch Program. Eligibility for free or reduced-price lunch can be determined through a variety of methods including the electronic direct certification process or completion by a parent or guardian of a free and reduced-price lunch application. A student with an approved application on file for a free or reduced-price lunch is qualified to be reported to the Department as economically disadvantaged.
- Resident of a Household in which a Member is Eligible for Free or Reduced-Price Lunch. Students who have not submitted an application for free or reduced-price lunch or who have not been directly certified as eligible but reside in a household in which a member (e.g., sibling) is known to be eligible for free or reduced-price lunch via an approved application or through direct certification.
- Public Assistance. Students who are known to be recipients of or whose guardians are known to be recipients of public assistance. A source for determining whether a student's family is receiving public assistance is the Education Monetary Assistance Distribution (EMAD) system.
- Title I Application. Students whose parents or guardians have completed a Title I student income form and meet the income guidelines specified

The percentage of students who were eligible for free lunches based on other certification processes in the Youngstown City School District for the 2023-2024 school year was 62%.¹⁰ (More on CEP Eligibility in Appendix E).

District Report Card

There are six components that are used to calculate the district's overall grade: Achievement, Progress, Graduation Rate, Gap Closing, Improving At-Risk K-3 Readers, and Prepared for Success.

Overall, the Youngstown City School District received a score of 2 stars out of 5 on the metrics that the Ohio Department of Education and Workforce use to determine a district's school quality grade. The 2 stars means that the district "needs support to meet state standards".

Achievement

This component represents the number of students who pass state tests in addition to how well they performed on those tests. It is broken down by **Performance Index**, which measures the test results of all students and not just those who score proficient or higher, and **Indicators Met**, which measures what percent of students have passed the tests.

• The district had a Performance Index of 49.4% on the 2023-2024 report card.

This number has been declining since 2017 (58.0%). In 2021, the performance index had dropped starkly to 32.4% and GOPC suggested that the severity of the decline in score could be attributed to the pandemic, seeing as the index stood at 56.0% in 2020. Scores have recovered somewhat, but have yet to achieve pre-pandemic levels. Overall, the achievement score received **1 out of 5 stars** for the 2023-2024 school year.

Progress

This component examines the growth of students based on previous performance compared to the expected growth on average in Ohio's State Tests. Within Progress, students are split into 4 measures which are weighted for the final score: i) progress for all students, ii) gifted students, iii) students with disabilities, and iv) students whose academic performance is in the lowest 20 percent of students statewide.

According to the 2023-2024 Report Card publication in English Language Arts,

- Grades 5 through 8 all met or exceeded student growth expectations, as well as overall.
- The 4th grade showed significant evidence that students made less progress than expected by a large margin. (Note: These students were kindergarteners when the schools went remote in March 2020 due to the pandemic.¹¹)
- High School showed significant evidence that students fell short of growth expectations by a large margin.

In Mathematics,

- Grades 5 through 8 either met or exceeded student growth expectations.
- 4th Grade fell short of student growth expectations, while 8th Grade exceeded them.
- High School students exceeded expectations for Geometry by a large margin, and met expectations in Algebra. Value data was not available for Mathematics I or II.

In Science

- 8th grade was the only group to meet student growth expectations.
- 5th grade fell short of growth expectations by a large magnitude.
- Data was not available for 4th, 6th or 7th grades.

High School students are meeting expectations for Biology; however, students are falling behind expectations "by a large magnitude" in American History and Government. Overall, the district received **2 out of 5 stars** on Progress for 2023-2024.

Graduation Rate

This component is composed of the percentage of students who successfully finish high school with a diploma in either four or five years. The Four-Year Graduation Rate (60% in the calculation) is weighted slightly more than the Five-Year rate (40% in the calculation).

• As of the 2023-2024 Report Card publication, Youngstown City School District has a 4year graduation rate of 86.3%.

The graduation rate has remained steady overall, and has decreased minimally since the 2020-2021 school year when the graduation rate was 87.3%. Youngstown City School District received **2 out of 5 stars** in the Graduation component of the 2023-2024 Report Card.

Gap Closing

This component measures how well schools meet performance expectations for the most vulnerable populations of students in English language arts, math, graduation, and how well schools teach English learners to become proficient in English. The student groups that are represented include: groups based on racial and ethnic demographics (i.e., White non-Hispanic, Black non-Hispanic, Hispanic, American Indian/Alaskan Native, and Multiracial) as well as students that are economically disadvantaged, students with disabilities, and English learners.


Overall, the district had a gap closing score of 6.7%, earning 4 out of a possible 60 points in this category (**1 out of 5 stars**).

- No student groups met their English Language Arts Achievement goal.
- No student groups met their Math Achievement goal.
- No student groups met their English Language Arts Growth goal.
- No student groups met their Math Growth goal.
- 4 out of 8 student groups met their Graduation goal.
- No student groups met their English Learners goal, or showed improvement from the prior year.
- No student groups met their Chronic Absenteeism goal.

Improving At-Risk K-3 Readers

"Improving At-Risk K-3 Readers" is a component that examines how successful the district is at helping struggling students get on track toward proficiency in reading in the third grade and beyond (Figure 9). Third grade improvement evaluates students that were previously "off track" to see if they met the score for "on track" on the third grade English language arts test, as opposed to year-to-year comparison.

According to the Third Grade Reading Guarantee, despite only 40% of students scoring proficient on the state English Language Arts test, 89% of students met requirements for promotion to the 4th grade. Whereas "On/Off Track" is a comparative measure of each student's year-to-year improvement, score on the English Language Arts test is an objective, pass-fail metric.

Overall, the Youngstown City School District earned a 52.7% in the Early Literacy component of the 2023-2024 District Report Card. The district received **1 out of 5 stars** for the overall Early Literacy Component.

Prepared for Success

Lastly, this category examines how well students are prepared for future opportunities, whether that is preparing for work or college, or training in a technical field. There are three **Primary Measures**: i) whether or not a student receives an Honors Diploma, ii) ACT or SAT remediation-free scores, or iii) 12 points through an industry-recognized credential in one of 13 high-demand career fields. There are also **Bonus Measures** for advanced placement tests, international baccalaureate tests and college credit plus.

• Of the graduation cohort (333 students) in the 2022-2023 school year, 227 demonstrated post-secondary readiness giving the district a composite score of 68.2%.

Of the 2023 graduation cohort, 15% took the ACT, however only 0.9% of test-taking students received a score that indicated they did not need remediation support. Of the graduating cohort, 65.8% of students took the SAT, but only 2.4% of those students received remediation-free scores. Within the graduating cohort, 60.4% of students received 12 points through an industry-recognized credential, however only 2.4% of students received an Honors Diploma.

Higher Educational Attainment

Across most populations within Mahoning County and Youngstown, higher education degree attainment is occurring less frequently than elsewhere in the state. Less than 20% of the White alone population within Youngstown has attained a Bachelor's Degree or Higher in 2023, which is also less than that of the county. Degree attainment for Black and Hispanic or Latinx populations is consistent across the city and county, although still lower than state trends. However, within Youngstown and Mahoning County, Asian residents are outperforming peers statewide.

Conclusion

The city of Youngstown is experiencing higher rates of population decline when compared to previous observed periods. However, Mahoning County's population is beginning to stabilize.

Significant economic inequities between the city and county and state remain. Because of the racial demographics of the city, versus the county and state, these inequities are highly racialized.

Housing overall has seen multiple successes:

- Homeownership has increased from 2020 to 2023.
- There is notably less permanent vacant housing within Youngstown since 2022. This is a major success for the city and should be celebrated as such.
- Average sales prices have more than doubled within Youngstown, another success, especially in comparison to the state overall, where average sales prices have decreased. (\$159,703, 2024; \$65,150, 2022),

However, there are areas that need improvement as well. Overall, rents have increased throughout Mahoning County, but wages for White alone and Black or African American households have not shown the same growth. The percent of households living below poverty has increased in both Youngstown and Mahoning County. This is a sign that continued efforts to assist racial minorities are still necessary.

The number of certified minority, women, and EDGE certified businesses have all doubled within Youngstown since February 2022. The Health Care and Social Assistance industry has grown in Youngstown; Retail Trade and Administrative Services have fallen out of favor in exchange for Public Administration and Educational Services.

School report card metrics show that the district needs supportive intervention to improve metrics and assist in meeting student expectation goals.



Population Change in Youngstown and Mahoning Co., from 2020 to 2023





Hispanic and Latinx households are seeing the worst financial outcomes within the city. Only 18% of Hispanic and Latinx households in Youngstown earn more than the median income for White alone households (\$45,000), while 33% of Black or African Americans earn the same.

Black or African American households currently have the lowest median income in the county, sitting within the \$25,000 to \$29,999 income bracket (Youngstown, \$27,986; Mahoning, \$29,685).

Housing Cost Burden for Renting and Homeowner Households, 2017-2021

Housing cost-burden is when a household pays 30% or more of its income to housing expenses (mortgage/rent, utilities, taxes/fees). The most recent data available is aggregated from data collected from 2017 to 2021 and does not adequately reflect the ongoing stress the pandemic and post-pandemic trends have put on renters and some homeowners.

The most recent data; which have limited value because of their age, suggests 49% of Youngstown city renters paid more than 30% of their income to housing expenses). Sixteen percent of all Youngstown city homeowners paid more than 30% of their income to housing expenses.

Housing Wage for Renting Households, 2024


In Mahoning Co (the smallest geography available), the hourly wage necessary to afford a 2bedroom, fair market rate apartment has increased to \$16.19/hour (+\$2.35 since 2020). A household earning the average renter wage in the county needs to work 63 hours a week in order to afford the typical 2-bedroom fair market rent of \$860/month (National Low Income Housing Coalition). A minimum wage earner would need to work 1.6 jobs to comfortably afford a 2-bedroom fair market apartment.

Households Living at or Below the Federally Designated Poverty Rate, by Race, 2023 In Youngstown, 36.2% of households were below the poverty level (the poverty level for a single adult with two minor children in 2023 was \$24,526 or below). Youngstown's household poverty rate is nearly double that of the county (18.3%) and significantly more than the state (13.2%). While the state poverty rate has slightly declined, both City of Youngstown and Mahoning Co.'s poverty rates have continued to increase since 2020.

The Progress Component measures the academic performance of students compared to expected growth on Ohio's State Tests. 8th Grade was the only grade from 4th through 8th within the district to exceed student growth expectations. High School is meeting expectations for Algebra and Biology, exceeding expectations by a large magnitude in Geometry, and falling behind expectations by a large magnitude in English II, American History, and American Government (**2 Stars overall**).

The 4-year graduation rate for Youngstown City School District in the 2023-2024 school year was 85.9%.

Appendix B

Household Income

Household income is defined by the Census Bureau as income of a household in the past 12 months. This number includes the householder and all other individuals aged 15 and older who have income, regardless of relation to householder. This number is *not* family income, as many households are filed by a single person, despite familial relations. Bear in mind that, although household income is a composite of the past 12 months, it is only representative of the household at the time of the interview. This means that people who were members of the household during the year but no longer reside at the household at the time of reporting are not counted. The opposite also holds true, wherein people who did not reside in the household for the past 12 months but are members of the household at the time of the interview are included in the household income. However, overall the compositions of households tended to have no change over the past 12 months at the time of the interview.

Median household income is the division of all households into two equal parts: one half of all households falling above the median, and the other half below. The distribution of households and families includes those with no income, while individual reporting is based on individuals 15 years old and older with income.

Health Care and Social Assistance

This sector contains establishments that provide health care and social assistance for individuals. Health care and social assistance are combined in this industry because it can be difficult to distinguish between the two activities. Industries within this sector do anything from providing medical care exclusively to only providing social assistance or some amalgamation of the two and contains the following subsectors: Ambulatory Health Care Services, Hospitals, Nursing and Residential Care Facilities, and Social Assistance.

Education Services

This sector comprises specialized establishments that provide instruction and training in a wide variety of subjects, such as schools, colleges, universities, and training centers. These establishments may be privately owned and operated for profit or not for profit, or they may be publicly owned and operated. They may also offer food and/or accommodation services to their students

Manufacturing

Within the manufacturing sector are establishments that are engaged in the mechanical, physical, or chemical transformation of materials, substances, or components into new products. This are the plants, factories, and mills that typically use power-driven machines and materials-handling equipment. Reflective of the region's rust belt history. However, establishments such as bakeries, candy stores, and custom tailors, which focus on transforming materials or substances into new products by hand or in the worker's home and engage in selling products from the same premises where they're made, might also be counted in this sector.

Public Administration

This sector consists of establishments of federal, state, and local government agencies that administer, oversee, and manage public programs and have executive, legislative, or judicial authority over other institutions within a given area. Establishments in this sector typically are engaged in the organization and financing of the production of public goods and services, most of which are provided for free or at prices that are not economically significant.

Accommodation and Food Services

This sector is composed of establishments that provide customers with lodging and/or preparing meals, snacks, and beverages (intended to be consumed immediately). These services are combined into a single sector to reflect the fact that these two activities are often combined in a single establishment.

Appendix D

Appendix E

About the Community Eligibility Provision (CEP)

In the Ohio Department of Education's *Economically Disadvantaged Students: A Review of Definitions and Methods Across States* report they define the **Community Eligibility Provision** and explain the role that it plays in determining whether or not students qualify as economically disadvantaged. Their description reads as follows:

Student eligibility for the USDA's Free and Reduced-Price Lunch (FRPL) program traditionally has been the most common criterion used by states for determining a student's economically disadvantaged status (income limits are federally set at 130% for free and 185% for reduced-price meals). Another USDA program, the Community Eligibility Provision (CEP), has allowed increasing participation by districts and schools in school breakfast and lunch programs over the past eight years but has introduced further complications for using FRPL eligibility as the primary means of identifying economically disadvantaged students. CEP, in combination with complementary state reporting rules, allows participants to report all students as economically disadvantaged without requiring income verification for each student.¹²
